

## Are you or someone you love eligible?

- 16 million Veterans or spouses are potentially eligible including 9 million from Vietnam.
- Wartime Pension with Aid and Attendance benefit is paid for by the United States Department of Veterans Affairs.
- Because this benefit is so unknown, only an estimated 2% of Veterans who may be eligible are receiving benefits.
- Claimants applying for Veterans benefits may obtain free assistance in filing an application from VA recognized advocates for Veterans.
- No person or company, including Patriot Angels, can charge a fee with the preparation, presentation, and prosecution of a claim.

April 6, 1917-November 11, 1918

### WWII

December 7, 1941-December 31, 1946

### Korean War

June 27, 1950-January 31, 1955

### Vietnam War

August 5, 1964-May 7, 1975

(Boots on ground begins 1955)

### Persian Gulf War

August 2, 1990-Present Day

## Monthly Pension Amounts

### Veteran

Aid and Attendance (no dependents)	\$2,300.00
Aid and Attendance (one dependent)	\$2,727.00

### Surviving Spouse

Aid and Attendance (no dependents)	\$1,478.00
---------------------------------------	------------

### Veteran Married to Veteran

Aid and Attendance (no dependents)	\$3,649.00
---------------------------------------	------------

\*Note\* To qualify for pension benefits, claimants' countable income must not exceed annual pension limits that are set by statute. Such limits may vary based on whether the claimants are Veterans or survivors, as well as their family composition and medical expenses.
